MGIC adopts underwriting updates from Fannie Mae® Announcement SEL-2017-04 for MGIC Go!™ loans

We are adopting the updates Fannie Mae communicated in its <u>Announcement SEL-2017-04</u>, for MGIC Go! loans. These changes do not affect our Underwriting Requirements.

Changes include:

- Student loan qualifying payment requirements
 - o Payments provided on credit reports may be used for qualifying
 - o If a credit report reflects no payment or \$0, then either use 1% of the outstanding student loan balance or calculate a fully amortizing payment using documented loan repayment terms
- Debts paid by others may be excluded
 - o Replaced "Co-Signed Debt" section with "Debts Paid by Others"
- Asset documentation to allow for truncated account numbers

MGIC Go! Underwriting Requirements apply to loans with a valid Loan Product Advisor® Accept or DU® Approve response. Our Standard Underwriting Requirements apply to loans that are not processed through an Agency AUS or are not eligible for MGIC Go! Please refer to our <u>Underwriting Guide</u> for complete requirements.
