## Order Delegated MI through Mortgage Cadence MCP<sup>®</sup>

**Note** – Starting with MCP 2.0, MCP clients can either use the legacy version of MGIC MI (MISMO 2.3.1) or use the new version or MGIC MI 3.4 Version (MISMO 3.4). Usage of MGIC MI 3.4 Version may require some additional setup by your MCP administrator and Mortgage Cadence.

### 1. Order New Service

In the Actions bar, select **Services > Mortgage Insurance > Order New Service**.

On the **Order New Service** screen, select **MGIC MI 3.4 – Delegated** or **MGIC Delegated**.

Complete the necessary information.

Click **Order Service**.
